



APIS OPERATIONAL HIGHLIGHTS (Q-o-Q) SEGMENT-WISE REVENUE MIX








APIS OPERATIONAL HIGHLIGHTS (Q-o-Q) MARKET-WISE REVENUE MIX









Formulations OPERATIONAL HIGHLIGHTS (Q-o-Q) REGION-WISE SALES BREAK-UP













APIS OPERATIONAL HIGHLIGHTS (Y-o-Y) SEGMENT-WISE REVENUE MIX









APIS OPERATIONAL HIGHLIGHTS (Y-o-Y) MARKET-WISE REVENUE MIX





Formulations OPERATIONAL HIGHLIGHTS (Y-o-Y) REGION-WISE SALES BREAK-UP








Formulations OPERATIONAL HIGHLIGHTS (Y-o-Y) PRODUCT-WISE REVENUE MIX Y-oY








